INTRODUCTION

E-COMMERCE DEPARTMENT

STEP 1: UNLOADING AND SECURITY ENTRY

Security entries are first check details of transporters, the parcel checked for damages. Material in warded and transport checking next supply plant, from which place its coming, receiving plant; we are the receiving planter and product coming for us.

STEP 2: UNPACKING AND PHYSICAL VERIFICATION

In receipt first check the individual product for model and quantity enter invoice and match it. The SAP program is the software which is used for the physical verification.

STEP 3: SEGREGATION

Check the docket number and categories for each product and check the delivery number, model and total head quantity.

STEP 4: DATA ENTRY

If any problems in status are noted to check and enter the delivery number and quantity in data entry excel.

STEP 5: IMAGE CHECKING

Check whether the image available is as same as the physical product and whether the bar code is also similar.

STEP 6: BINNING

Binning is a storage area and binning process are GR-verification. Now ready to binning and commodities are allotted racks until it demanded.

STEP 7: PICKING

Picking is nothing but customer order placed in online and picked with the item wise strip given articles are picked.

STEP 8: SHIPPING AND ARRANGEMENT

Shipments there are of two types. One is the NDD, Next day delivery (using power 1) and the other one is the DL, 3 days delivery (using power 21).

STEP 9: QUALITY CONTROL

The quality inspection checking goes through the process which includes the Spacer removing, check whether it is a running condition, and check if any issues are available.

STEP 10: BILLING

First update and image checking enter invoice no and customer delivery type express or normal delivery, and after that select box size for packing and send it to prepack.

STEP 11: PRE PACK

Shipment insertion and check model, invoice no and order no, after checking all this process written invoice no up on the box.

STEP 12: CAMERA PACKING

Bubble sheet wrapping and show the product to camera and invoice copy finally pack the product and send to dispatch.

STEP 13: DISPATCH

All packed goods are security should send the goods with proper documents and through the transportation service.

STEP 14: COLLECTION

Check the AWB, Airway bill number and delivery no and transport details like the Blue Dart are maximum customer opens and security should enter the proof of delivery.

STEP 15: CAMERA OPENING

Show the airway bill no and check the product if any damage is there and verify the model and our physical product.

STEP 16: REFUND AUTHORISATION

Refund is the first check the QC and if it is pass and permit refund other discrepancies are mailed to concerned authority.

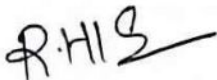
