A STUDY ON THE ROLE OF MANUFACTURE AND FINANCE DEPARTMENT OF TITAN COMPANY

INTRODUCTION

Titen Interched Teneshy, focused largely on exposts to European and American markets, in an effective in increase its foreign exchange reserves. In the early 1990s, India's exchange cross was resolved, and Titan Company shifted the focus of the brand to Indian market. A pilot plant was set up in August 1992 and the production began in 1994, and Tanishq's first store opened in 1996. Tanishq was the first sewellery retail chain in India.

MANUFACTURING DEPARTMENT

It is primarily responsible for implementing and operating the production system in order to produce the product. As how the process of making of gold is done in the manufacture department in our company and produced it.

Step 1: Melting of gold

The melting point of gold is 1064 degrees Celsius or 1943 degrees Fahrenheit. This is one of the highest melting points of any metal, and it is because of this resistance to heat- as well as its conductivity- that gold is used so prolifically in electronics.

Step 2: Refining the gold

The purpose of this refining is to remove any remaining impurities. The crude gold is melted and then treated with chloride. This converts any foreign elements or minerals still in the gold into chloride, which will then naturally drift off the gold. The result of this process is 99.5 percent pure gold.

Step 3: Align defining

Although gold is the most noble of the noble metals, it still forms many diverse compounds. The oxidation state of gold in its compounds range from -1 to +5. Alignment of gold nanorods yields strong polarization dependent extinction, and use of magnetic fields is appealing because they act through space and can be quickly switched.

Step 4: casting of gold

Gold casting is a part of the jewellery creation process. It allows designers and jewellery stores to take an idea or design, create a mold, and eventually end up with a physical reproduction of the final product. Melt an appropriate amount of either gold or silver in an appropriate pouring crucible.
