#### TDS AND CALCULATION OF TDS

The salary will be calculate according to the slab rates, the scrap will be calculated up to 1% and the material with the percentage of 0.1%. The 1st date of filing the TDS is on the first week of the upcoming month. Sub-contract the person charge only for labor cost of 2%.

#### COMMISION

If the agent has the pan card the commission registered pan will be up to 10%. and if an individual holds the pan card, then it will be up to 5%. The percentage f benefit given by the government of encourage export will different from UNO MINDA (only for seating) will be 1.8%.

#### THE DOCUMENTS USED IN THE COMPANY

There are 3 bills such as invoice, shipping bill and bills of loading all this has to be submitted to the bank to collect the payment for the calculation of the upcoming financial calculation. The customer has to pay the amount within 90 days after delivery. The person who collects the goods should collect the lodgments number. The lodgment number will be generated within 10 days.

#### SCRAPVALUE

The scrap value amount is collected from the buyers and the company will pay the TDS to the government and the company calculates the tds according to the requirement of the products they prepare and will be applied for the formation in deep of scrap values.

### CALCULATION OF THE VALUES

This is only for seating department in the company and the Government will pay1.3%a duty drawback it is calculated on FOB value and it termed as INR. The main benefit is RODTEP 5% it is also calculated ass FOB.

### GST AND OTHER REPORT

The goods and service tax is calculated according to the process of goods sold they are been calculated under CGST, IGST, SGST UTGST. The business-to-business goods are calculated as the commercial goods. The commodity of the goods is calculated as 0% or no tax for the agriculture, goods ,5% for the scrap value, 12% for ink ,18% for the maximum product like steel etc...,

Invoice of the company is newly created if the company's turnover is mor than 5 cr...And the bank will provide the information regarding the payments which are received by them. By verifying the lodgment number, they will pay back the amount to the supplier.

Working capital is prepared monthly.
