Sales invoice

A Sales invoice is an accounting document sent by a provider of goods or services to a purchaser. Sales invoice should includes Parties name, Invoice no, Invoice Date, Description of goods, HSN code, Quantity rate, Total amount (Basic amount + GST)

Credit Note

A Credit note is issued when a seller locates a discrepancy in an existing invoice, for instance, by charging an incorrect amount or when a buyer returns the goods. It represents the amount that was paid in excess by the buyer and is due to be returned to them by the seller.

Purchase Invoice

A Purchase invoice is a document that a seller sends to a buyer to request payment for goods and services. The invoice should include the date of the transaction, the quantity and type of the goods or services sold, the prices of each items, any discounts or sales tax, and the total amount due./ The invoice should includes the parties name or company name, items name, quantity, rate, GST calculation, total amount.

Purchase

A Purchase involves the acquisition of goods or services in exchange for payment of some kind. The payment of some kind is usually in cash or credit (to be paid later).

Purchase in Accounting

Purchase of goods and services includes the value of all goods and services purchased during the accounting period for resale or consumption in the production process.

Types of Purchase

Debit Note

A Debit Note is a commercial document issued by a buyer to a seller as a means of formally requesting a credit note. Debit note acts as the source document to the purchase return journal. Debit note should including the party name, quantity, rate, GST, total amount.
