- ➤ The finished products are distributed to Bata to Bata, Contract to Bata and Third party stock purchase.

#### **INWARD PROCESS:**

- > The products will receive from manufacturing units to retail distribution centre through transport.
- The driver has to submit the documents to the retail distribution centre security gate.
- > The security verifies the documents and their location.
- The security has to maintain shipment details in security gate in inward register.
- The security has to create the inward gate pass and hand over all the documents to the supervisor.
- > The security has to instruct transporter to place the vehicle at the receiving bay.
- ➤ Unloading to be done in the presence of warehouse security and transport driver.
- The product count has to be done with the unloading sheet, supervisor checks the condition of the boxes and if any damages or tampering done is transit.
- > The supervisor gives the physical inspection sheet to checker team.
- ➤ Checker team has to verify whether if any damage, shortage or excess found in consignment against the invoice bill.
- > Supervisor has to handover all the receiving documents to inbound manger.
- ➤ Invoice bill contains both supplier details and receiver details. Invoice number varies from vendor to vendor.
- ➤ Invoice bill contains purchase order number, article name, size and pairs, type, sale price and all the details of the vendors purchase order.

## ADVANCE SHIPMENT NOTE (ASN)

ASN is already created by vendors. After the creation of load number, the ASN labels are printed. Paste the ASN in invoice bill. Scan the ASN, then LPN (Outer box), and the SPN (Mono). After the process of scanning, the products are sent to Put Away.

#### PUT AWAY:

- ➤ The purpose of Put Away is to keep GRN stock on right location for optimum picking accuracy and space utilization.
- > Put away helps in maximizing order fill rate and overall warehouse productivity.
- Floor incharge would be the person responsible to execute the activity.
- Supervisor has to advice the Put Away team for moving the goods to respective locations.
- Newly arrived stock is placed at the back so that FIFO (First In First Out) is maintained.
- Put Away stickers are visible from the front to ease picking process.
- The products are placed on the palette, scan the palette ASN and LPN of all the boxes and the location where the goods are placed.

- There are two types of Put Away: HDR (Heavy Duty Rates) and SAR (Single Angle Rates).
- HDR involves bulk of products and SAR involves Single Pairs of Product.

### **INVENTORY HANDLING:**

- The purpose is to ensure stock accuracy at all time in warehouses.
- Inventory process involves stock group, stock category, stock item, unit of measures, Godown.
- The process covers the periodic physical stock taking of all SKU stored in the warehouse.
- When goods are pick packed, other goods should be refilled in the location.

## ORDER ITEM HANDLING:

- Orders received from distributor based on the store sale, the order will fulfil.
- The products are arranged based on the location. Based on the order pick pack process will done. System will suggest that where we have to pick the product.
- Picker should scan the task number against order.
- After picking the product, auditor will verify the each and every quantity of the LPN.
- Print the detailed label against the LPN.
- > After packing the LPN, staging area to dispatch area.

## **OUTWARD PROCESS:**

- From the staging area, the products are dispatched to the respective stores.
- The physical checking / audit and the documentation are done on the basis of route wise planning.
- > The products are loaded into the vehicle; receive the acknowledgement from transporter and outward gate pass.
- > The transporter has to register the exit entry in security gate.
- > Dispatch the products based on the routes and their locations. It is supervised by outbound manager.
- Distributing the goods to more than 800 stores.
