If CGST/SGST/UTGST is to be applied then CGST and SGST both amount are half of the total GST amount. For example, GST including amount is GST rate is 5%.

TAX INVOICE VOCHER TYPE

Tax invoice broadly contain details like description, quantity, value of goods or services, tax charged there on and other particulars as may be prescribed. Tax invoice is a primary evidence for recipient to claim input tax credit of goods and services.

BILL OF SUPPLY

Bill of supply is an invoice issued for-

- Exempted supply of goods & services
- Supplies made under composition scheme

Bill of supply broadly contains details like description, quantity, value of goods or services, tax charged there on and other particulars as may be prescribed.

How many copies of tax invoice will be required for supply of goods?

As per CGST rules, tax invoice is required to prepare in TRIPLICATE for goods-

- The original copy being marked as ORIGINAL FOR RECIPIENT
- The duplicate copy being marked as DUPLICATE FOR TRANSPORT
- The triplicate copy being marked as TRIPLICATE FOR SUPPLIER

Duplicate for transport copy will not be required in case supplier obtains an invoice reference number.

Under the GST regime, an "invoice" or "tax invoice" means the tax invoice referred to in section 31of the CGST act, 2017. This section mandates issuance of invoice or a bill of supply for every supply of goods or services or both.
