Ragging consists of one or more of the following acts:

- Any conduct by any student or students whether by words spoken, written or by an act
 which has the effect of teasing, treating, and handling, with rudeness a fresher or any other
 student.
- Indulging in indiscipline activities by any student or students which causes annoyance, hardship, physical, psychological harm, or to raise fear, apprehension thereof in any fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary course do and
 which has the effect of causing or generating a sense of shame, or torment or embarrassment
 so as to adversely affect the physique or psyche of such fresher or any other student.
- Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by the students.
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that affects the mental health and self-confidence of a fresher or any other student
 with or without an intent to derive a sadistic pleasure or showing off power, authority or
 superiority by a student over any fresher or any other student.

The Institution shall punish a student even found guilty of ragging herein under:

- Suspension from attending classes and academic privileges.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation process.
- Debarring from representing the institution in any regional, national or International meet, tournament, youth festival, etc.
- Suspension/Expulsion from the hostel.
- Cancellation of admission.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

Ragging consists of one or more of the following acts:

An Anti-Ragging Committee is typically established by educational institutions to prevent and address incidents of ragging within the campus. The committee plays a crucial role in creating a safe and conducive learning environment for students. The duties of an Anti-Ragging Committee often include:

- Refers to a form of initiation ritual or social interaction that occurs in educational institutions, especially in colleges and universities.
- Considered to be a negative practice and is prohibited in many educational institutions due to its potential for harm and harassment.
- Allowing seniors to engage in casual conversations with juniors, sharing experiences, and offering guidance in a friendly manner.
- Emphasizing to the students about ragging which can sometimes escalate to more serious and harmful activities, including physical, emotional, or psychological abuse.
- > Prohibiting any form of ragging to ensure the well-being and safety of students.
- Addressing the appropriate authorities to ensure a safe and healthy learning environment.
- Serves as a point of contact for students who wish to report incidents of ragging.
- Establishing confidential mechanisms for reporting, ensuring that complainants feel safe and protected.
- Providing support and counseling to victims of ragging, helping them cope with the emotional and psychological effects of the incident.
- Monitors the campus environment regularly to identify any potential instances of ragging and assess preventive measures' effectiveness.

The Institution shall punish a student even found guilty of ragging herein under:

Upon receiving a complaint, the committee is responsible for conducting a prompt and impartial investigation into the alleged incident which may involve in gathering evidence, interviewing witnesses, and ensuring a fair and transparent process. If the committee finds a student or group of students guilty of ragging, it recommends appropriate disciplinary actions. Depending upon the severity of the incident, the actions may include,

- A formal verbal warning may be issued to the individuals involved, emphasizing the seriousness of the matter and advising them to cease such behavior immediately.
- ➤ In cases of repeated or more serious incidents, a written warning may be issued. This warning typically outlines the consequences of further involvement in ragging activities.
- Perpetrators may be required to attend counseling sessions to address the underlying causes of their behavior and to encourage empathy for the victims.
- Perpetrators might be assigned community service tasks within the institution or local community as a means of making amends and contributing positively.
- Imposing fines on the individuals involved in ragging can serve as a deterrent. The funds collected may be used for anti-ragging awareness programs or support services.
- ➤ In more severe cases, temporary suspension from the institution may be implemented. During this period, the individuals are not allowed to attend classes or participate in academic activities.
- > Expulsion from the institution is a serious consequence and may be applied for extreme cases or for repeat offenders who have not responded to previous disciplinary measures.
- The privilege of staying in the institution's hostel may be revoked as a disciplinary measure, requiring the individuals to find off-campus accommodation.
