Whereas the First Party and the Second Party have made this Memorandum of Understanding for collaboration

1. **"St. Joseph's College of Arts & Science for Women"** is willing to enter into a Memorandum of Understanding (MOU) with Dazz for the skills enhancement training program through the technology platform or other face to face initiatives.
2. To conduct training programs and provide access to employability enhancement related activities through blended learning model. 4. To enable students of **"St. Joseph's College of Arts & Science for Women"** to gain access to resources that would enhance their employability.
5. To ensure that all their students adhere to training schedule.
6. To provide all the support services and facilities to Dazz during the conduct of the said Training Program.
7. To coordinate with Dazz and facilitate conduct of all the assessments including the assessment to be conducted by the external agency (if any) identified by Dazz, as per schedule communicated by Dazz.
8. To facilitate placement of students with their client/ customer companies in suitable positions and also recruit for their own requirements.
9. The College shall not write/publish any material or use any logos/names of Dazz / in any of the publications without prior written consent and approval from Dazz.

**TERM:**

- a) This MOU shall be effective for a period of five (5) years from the date of execution of this agreement unless a written notice to terminate or amend these agreements given to the other party six (6) months in advance.
- b) It is expressly agreed that neither party shall be liable for damages that they might cause each other as a result of a forceful suspension of a collaboration program. Causes for forceful suspension must be explicitly set forth in the action plans.
- c) This agreement may, at any time during its period of validity, be terminated by either party upon one month's prior notice to the other in writing.
