Whereas the First Party and the Second Party have made this Memorandum of Understanding for collaboration



- c) This agreement may, at any time during its period of validity, be terminated by either party upon one month's prior notice to the other in writing.

Each of the parties accepts and declares that information from the other party is of confidential nature, is the exclusive property of the latter and has been or will be disclosed to the former solely with the purpose of enabling the full accomplishment of the present Agreement.
